

## The Table of Crimes and Legal Punishments Provided in Articles Four, Five, and Eight

Of The Law Amending the Law on Combatting Illicit Drugs With the Latest Amendments

Legal Provision	Amount of Drugs	Legal Punishment
Article 4(1)	Up to fifty grams	Eighty Thousand Rials monetary penalty for each gram and one lash
Article 4(2)	More than fifty grams up to five hundred grams	(Four million Rials monetary penalty and twenty lashes, and in the event that the court deems fit, up to three years imprisonment) * (For amounts over fifty grams: For each additional gram, one hundred and two thousand Rials shall be added to the monetary penalty, and for each additional ten grams, one lash shall be added to the lashes)

Article 4(3)	More than five hundred grams up to five kilograms	(Three years imprisonment and fifty million Rials monetary penalty and fifty lashes) * (For amounts over five hundred grams: For each additional gram, one day shall be added to the prison term, and thirty three thousand Rials shall be added to the monetary penalty, and for each additional two hundred grams, one lash shall be added to the lashes)

Article 5(2)	More than fifty grams up to five hundred grams	(Five million Rials monetary penalty and ten lashes) * (For amounts over fifty grams: For each additional gram, twenty two thousand Rials shall be added to the monetary penalty, and for each additional seven grams, one lash shall be added to the lashes)
Article 5(3)	More than five hundred grams up to five kilograms	(Two years imprisonment and fifteen million Rials monetary penalty and forty lashes) * (For amounts over five hundred grams: For each additional four grams, one day shall be added to the prison term, and for each additional one hundred and forty grams, one lash shall be added to the lashes, and for each additional gram, ten thousand Rials shall be added to the monetary penalty)

First offense: (five years imprisonment and sixty million Rials monetary penalty and fifty lashes) * (More than five kilograms: For each additional kilogram, four months shall be added to the prison term, and nine million three hundred thousand Rials shall be added to the monetary penalty, and for each additional two kilograms, three lashes shall be added to the total number of lashes)</p> <p>B. Second offense: (five years imprisonment and fifty lashes and expropriation of property) * (More than five kilograms: for each additional kilogram, four months shall be added to the prison term, and for each additional two kilograms, three lashes shall be added to the total number of lashes)</p> <p>C. Third offense: (Twenty five years imprisonment and one billion Rials monetary penalty and expropriation of properties obtained through commission of drug crimes) * (More than five kilograms: For each additional kilogram, four months shall be added to the prison term, and sixty six million Rials shall be added to the monetary penalty)</p>

Article 8(3)	More than one gram up to four grams	(Two years imprisonment and eight million Rials monetary penalty and thirty lashes) * (More than one gram: For each additional gram, one year shall be added to the prison term, four million Rials shall be added to the monetary penalty, and thirteen lashes shall be added to the total number of lashes.)



Article 8(4)	More than four grams up to fifteen grams	(Five years imprisonment and twenty million Rials monetary penalty and thirty lashes) * (More than four grams: For every additional gram, three months shall be added to the prison term, one million eight hundred thousand Rials shall be added to the monetary penalty, and four lashes shall be added to the total number of lashes.)
Article 8(5)	More than fifteen grams up to thirty grams	(Ten years imprisonment and forty million Rials monetary penalty and thirty lashes) * (More than fifteen grams: For every additional gram, four months shall be added to the prison term, one million three hundred thousand Rials shall be added to the monetary penalty, and three lashes shall be added to the total number of lashes.)
